How to Access the Historic Red Wing Podcasts

You can access all 28 historic Red Wing podcasts by visiting the City of Red Wing's website at

http://www.red-wing.org/historicpodcasts.html

or by scanning one of the QR codes located at each site with a smart phone or tablet (with a QR code scanner application). The QR code will take you to the podcast's web-page and gives you the option of watching the specific site you are at, or any of the other 27 sites.



The Red Wing Heritage Preservation Commission (HPC) has produced 28 podcasts featuring all of the historic buildings and sites featured in the *Footsteps through Historic Red Wing* walking tour booklet that are located in the Downtown and Heritage Mall Historic Districts. The narrated podcasts combine historic photographs, current photographs, video, maps, and other documents regarding Red Wing's history and the historic and architectural significance of each site.

The Red Wing HPC hopes the podcasts will highlight and bring awareness and appreciation to the great historic assets of Red Wing and the community's preservation efforts.

The historic Red Wing podcast project included the creation of a new podcast web-page http://www.red-wing.org/historicpodcasts.html on the City of Red Wing's web-site and a QR code (quick response code) system. Visitors with smartphones or tablets with a QR code reader application will be able to use this system to quickly link to the podcast project home page. The podcast home page has a link to the podcast created specifically for the property, a map, general information, and links to the other 27 podcasts created by the project. The QR codes will be displayed in a prominent location at each site.
