1. MN Dept. of Health Fee is a fee passed on to the customer from the State of Minnesota – This is billed once per year.
2. CESC is a non-taxable fee charged to residential and commercial customers for the collection of mixed solid waste.
3. Fuel Surcharge – Fee is collected to help offset the high cost of diesel fuel used for the refuse vehicles.

4. FEFC Charge is a fee that is being used to repay a bond for improvements to the Solid Waste Campus.

5. Stormwater Utility Fee – Fees collected are being used for storm water infrastructure maintenance.
