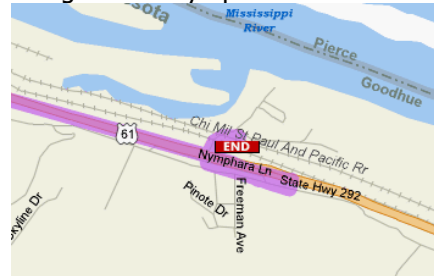

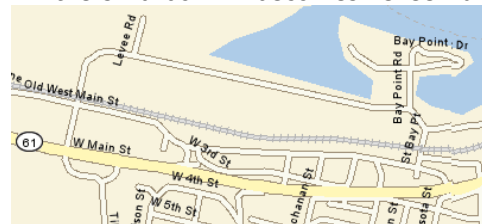
**Colvill Park**
